The sale of frozen semen will contain no warranty, guarantee or liability for Pangaea Farm or David Burke. All fees must be paid in full before **any** semen will be shipped. Mare Owner is responsible for all Frozen Semen shipping fees and expenses and agrees to return containers.
2. The determination of the mare's condition for breeding is the purchasers responsibility
3. Return of service: I understand and acknowledge that the return of service does not apply to the sale of Frozen Semen. _____ (Mare Owner initials)
4. Refund of Fees: The Mare Owner understands and acknowledges that there is no refund of fees whatsoever for the sale of frozen semen. _____ (Mare Owner Initials)
5. Warranty: Pangaea Farm is not responsible for lost, delayed, or damaged semen and makes no representations or warranties of any kind with respect to any semen furnished hereunder except that it is the Stallion's. _____ (Mare Owner Initials)

6. The mare owner understands that David Burke or Pangaea Farms reserves the right to refuse any contract for breeding at its own discretion. The Mare Owner also understands that this contract is non-assignable without the express written consent of David Burke or Pangaea Farms.

7. The Parties agree the mare Owner will assume all responsibility for the condition of the mare and will bear all risk of loss or damage to the mare whether by death, disease, injury, infection, or otherwise and by any cause whatsoever, and therefore agree to hold Pangaea Farms or any person employed or associated with Pangaea Farms harmless for any and all damages associated therewith. The Mare Owner will not be responsible or liable for any accident, disease or injury to the above-named Stallion.

8. Contract Execution: This contract is in duplicate. The Mare Owner or Agent must sign both copies and return them to David Burke. When signed by David Burke it will become a binding contract on both parties, subject to all the above terms and conditions
