This service is subject to the following conditions:

1. Terms: The overall Stud Fee for Harvard is \$2000.00. This Stud Fee includes up to two free collections of fresh semen for the duration of the two year contract. If over two collections of fresh semen are required by the mare to establish pregnancy the mare owner is then responsible for paying an additional fee of \$200.00 per additional collection required. Also included in the overall Stud Fee price is a \$400.00 non-refundable Booking Fee must be paid to David Burke when the Mare Owner returns this contract. The mare owner is responsible for all fresh semen shipping costs and must have a current Fed Ex account which will be billed directly, or provide us with a Credit Card number and expiry date. If the mare owned does not return or mail back the Fresh Semen shipping container to David Burke an additional fee of \$45.00 will be charged per box.

2. Balance of Stud Fees: Are due and payable before the first shipment of semen will be shipped to the mare owner or agent. Stud Fee is payable to David Burke.

3. Mare-Specific: The transported semen may be used only for the Mare designated on this contract, and all excess semen must be destroyed. Should the semen be used on any other mare than the one so designated on this contract without the express written permission of David Burke then this contract becomes null and void and no monies will be refunded. Foals may not be registered and breeding certificates will not be issued for any of the foals involved.

4. The Mare Owner or Agent agrees to confirm the mare's pregnancy 14-18 days post ovulation, reconfirm pregnancy 40-45 days post ovulation and report the live birth of the foal; reporting all findings to David Burke via Phone or Email.
5. If the mare does not conceive, or if at any time the mare is determined to be unfit to breed; the mare owner may substitute another mare upon Pangaea Farms written approval.
6. Live Foal Guarantee: A Live Foal is one which stands and nurses within 48 hours of foaling. In the event of the death of the foal, a Veterinary Certificate must be provided to the Stallion owner within 10 days. Immediate notification of death must be made to Pangaea Farms by verbal communication, e-mail or fax. If there is a failure to do so, the live foal guarantee provided will herein become null and void.
7. Should the above Stallion die, become unfit for service, or be sold; to fulfil this contract you will be provided with frozen semen of the Stallion. You may also elect to use fresh cooled semen of any other current Pangaea Farms owned stallion for substitution. If Stud fees differ for the substituted stallion the amount will be billed or refunded as the situation dictates.
8. The mare owner understands that David Burke or Pangaea Farms reserves the right to refuse any contract for breeding at its own discretion. The Mare Owner also understands that this contract is non-assignable without the express written consent of David Burke or Pangaea Farms.
9. The Parties agree the Mare Owner will assume all responsibility for the condition of the Mare and will bear all risk of loss or damage to the mare whether by death, disease, injury, infection, or otherwise and by any cause whatsoever, and therefore agree to hold Pangaea Farms or any person employed or associated with Pangaea Farms harmless for any and all damages associated therewith. The Mare Owner will not be responsible or liable for any accident, disease or injury to the above-named Stallion.
10. For mares being bred and boarded at Pangaea Farms, in the event of emergency, if a Veterinarian or Farrier is required for the Mare or her Foal, services of the same will be provided by personnel used by Pangaea Farms and will be at the mare owner's expense. All bills regarding above will be billed directly to the Mare Owner. Every effort will be made to contact the Mare Owner prior to any services being provided but failing to reach the Mare Owner services will be contracted at the discretion of David Burke or Pangaea Farms.
11. Mare care is billed at \$20.00 per day Dry Mare and \$25.00 per day Wet Mare (a Mare with a foal at side).

12. Breeding season will be from March 15th till July 30<sup>th</sup> 2017, unless other arrangements are made with David Burke or Pangaea Farms.

13. The length of term for this breeding contract will be for a period of two years from the original date of the contract.

14. Semen will be collected and shipped as soon as possible, following the request from the Mare Owner, Vet or Agent. Please note you must make requests for semen before 9:00 AM Eastern Standard Time to be able to ship via Fed Ex that same day. If not, there is an additional charge to deliver the shipment to the Fed Ex Office of \$60.00. Mare owners are responsible for all costs associated with shipping of the semen and must have a current Fed Ex Account that will be billed directly for the shipping costs. **Mare Owners must supply in writing the completed FRESH SEMEN REQUEST FORM (found on our website) with their Fed Ex Account Number, or provide us with a Credit Card number and expiry date. the exact delivery address and the recipient's telephone number.**

15. If the mare owner plans to use this breeding contract to attempt an Embryo Transfer, David Burke must be notified in advance.

16. Contract Execution: This contract is in duplicate. The Mare Owner or Agent must sign both copies and return them to David Burke. When signed by David Burke it will become a binding contract on both parties, subject to all the above terms and conditions.
